

Step-by-Step Instructions

Zachry Business Use Case:

Employees can access and review their online payslips in Oracle HCM on Wednesday mornings; however, payment delivery should be expected on Thursdays. Payment timing depends on the ACH posting schedule of the employee's bank institution.

Important Notes:

- If an employee does not set-up a payment method with a linked bank account, a pay card will be issued by default.
- Off-cycle pay will be delivered by Friday COB if corrections are received before 9AM CST on Thursday.
 Otherwise, adjustments will be processed on the following week's pay.
- Due to more accurate employee location tracking in Oracle HCM, taxes will be adjusted for employees.
- Non-taxable per diem will now be included in the employee's paycheck as a single payment method.




- 3. To view a payslip, check the box next to the associated pay date. Payslip details will be displayed in the right-hand side summary section. The **Earnings** and **Deductions** tabs provide detailed summaries and categories for amounts paid and deducted via a bar chart for comparison.
 - Four (4) payslips can be viewed on the bar chart at one time, displayed in date order, with the latest available date selected at the top.






4. To preview the PDF payslip, select **Payslip Preview** above the bar graph section. Select the **download action icon** within the payslip preview window for a PDF file.

Earnings Category examples:

- Gross Earnings = regular, overtime, taxable earnings
- Imputed Earnings = shows as paid but also shows in deductions
- Nonpayroll Payments = nontaxable per diem, expense reimbursement
- Employee Tax Deduction = Statutory like FIT, FICA, etc.
- Voluntary Deductions = see Other Deductions examples
- Pretax Deductions = see Pretax deduction examples
- Involuntary Deductions = garnishments, child support, credit debt, school load debt, etc.
- Domestic Assignment Premium
